### It's Construction season – Duluth and Two Harbors

It's going to be a busy and exciting summer for DRCC!

We are moving forward with the construction of two new, fullyaccessible homes. One of the homes will be in Duluth at 1810 Basswood Avenue North. Individuals who are currently living at the Wheeler home (near Wheeler Field) will be moving to the Basswood Avenue location. Construction began on April 23rd and we anticipate the home will be completed by this Fall.

The second home will be in Two Harbors at 421 4th Avenue – on the site of the old high school. The individuals who are currently living at Harbor 15 will be moving to the new home. Construction on this home began the first week of June and will also be completed some time this Fall.





Efforts have been underway for more than a year to make this happen. These efforts have involved finding suitable land, developing floor plans, and obtaining the necessary financing. A team of DRCC employees worked together to create a home design that will make a comfortable home for the individuals who will be living there. We worked to incorporate the many ideas into the final plans. The homes will include large individual bedrooms, two living room/family room areas, two dining areas, two bathrooms, and specialized equipment throughout to assist individuals who rely on wheelchairs and need physical assistance.

Watching these homes come together is exciting for everyone involved.


#### 2012 Legislative Session

Believe it or not, legislators actually addressed issues other than the Viking's Stadium during the 2012 legislative session. The Legislature quietly passed a Health and Human Services bill that was signed by the Governor. Fortunately, the state was not facing another budget deficit so the focus didn't have to be on finding more ways to reduce funding. Below are a few key highlights of what passed:

- The legislature delayed the implementation of a 1.67% rate reduction until the next biennium (2013). This rate reduction was passed last year and was scheduled to go into effect July 1st of 2012.
- The legislature delayed the implementation of the new statewide rate-setting system. The new system is intended to provide

equitable funding for individuals based on each person's support needs. Progress on developing the new rate system has been slower than projected.

- Plans to reduce the number of Foster Care beds in the state were modified to encourage voluntary reduction rather than the mandatory closure methodology that was passed during the special session.
- Modifications were made to housing rules opening up more options for individuals.



### Rory to the Capitol

On April 4, 2012, Rory Johnson had the opportunity to visit the

State Capitol for Disability Day at the Capitol. He, along with many other selfadvocates, boarded a coach bus and took the two-and-a-half hour ride to the capitol to meet with legislators. Rory also attended a disability



rally and listened to Governor Mark Dayton speak about the issues on everyone's mind. The issues included voter ID and pay cuts to PCAs.

Rory also had the chance to meet Representative Kerry Gauthier and Senator Roger Reinert. In his meeting with Reinert, Rory was able to discuss a letter he had previously written to the Senator that took Senator Reinert just two weeks to reply. Rory enjoyed touring the capitol and learning how to pull representatives and senators from session and is looking forward to more trips to the capitol in the years to come.

### Day at the Capitol

Each year ARRM (Association of Residential Resources in Minnesota) sponsors a Day at the Capitol. This event encourages constituents to meet and speak with their legislators on matters that impact their lives. This year a group from DRCC went down for the event. A large rally was convened in the Capitol Rotunda where par-

ticipants listened to a variety of speakers. The DRCC delegation spent some time watching the House of Representatives in session and then went to the Governor's Reception room where they met with Lieutenant Governor Yvonne

Prettner Solon, her chief aide Luke Kuhl and Senator Thomas Huntley.
